PFD PROVIDED BUSINESS SKILLS TRAINING AND TECHNICAL ASSISTANCE TO AGRICULTURAL LOAN RECIPIENTS, WHILE INTEGRATING MICROFINANCE AND HEALTH BY PROVIDING REPRODUCTIVE HEALTH MESSAGES AND LINKING BORROWERS TO HEALTH FACILITIES. ADDITIONALLY, NIGERIA HAS MADE STRIDES IN EDUCATING FEMALE SECONDARY STUDENTS THROUGH THE ANNE JOHNSON MEMORIAL SCHOLARSHIP FUND ESTABLISHED BY PFD. THE STRONG CORRELATION BETWEEN EDUCATION AND SOCIO-ECONOMIC STATUS OF WOMEN GLOBALLY MAKES THIS ESPECIALLY RELEVANT TO PFD'S MISSION.
